### Plan Information & Benefits

Patriot Travel Medical Insurance is designed to meet the needs of international travelers looking for temporary medical insurance coverage while traveling outside of their home country. In addition to medical benefits, the plan includes coverage for emergency medical and political evacuation, repatriation, and a choice of deductibles and plan maximums up to \$2,000,000. Patriot Group Travel Medical Insurance is available to groups of five or more, and the plan provides a 10% discount of the standard individual plan rates.

*The following is a summary of benefits and plan information for Patriot Travel and Patriot Group Travel Medical Insurance. The plans cover the Usual, Reasonable and Customary (URC) charges for eligible expenses in the area where you receive treatment, and are subject to deductible and coinsurance when applicable. <b>Sudden and Unexpected Recurrence of a Pre-existing Condition - Medical</b> <i>(for non-U.S. citizens only)</i>	Up to age 65: \$50,000 Lifetime Maximum for eligible medical expenses. Age 65+: \$2,500 Lifetime Maximum
<b>Sudden and Unexpected Recurrence of a Pre-existing Condition - Emergency Medical Evacuation</b>	Up to \$25,000 of eligible costs and expenses

<b>Adventure Sports Rider</b> <i>(Available to insureds up to age 65.)</i>	Age 0-49: \$50,000 Lifetime Maximum; Age 50-59: \$30,000 Lifetime Maximum; Age 60-64: \$15,000 Lifetime Maximum
<b>Enhanced AD&amp;D Rider</b> <i>(Available on the individual plan only. Available to the primary insured only.)</i>	Up to an additional \$400,000
<b>Citizenship Return Rider</b>	Up to the Maximum Limit
<b>Evacuation Plus Rider</b> <i>(Available on the individual plan only.)</i>	Up to age 65. Non Life-threatening Medical Evacuation: Up to a maximum of \$25,000. Natural Disaster Evacuation: Up to a maximum of \$5,000.
<b>Chaperone/Faculty Leader Replacement Rider</b> <i>(Available on the group plan only.)</i>	Up to \$3,000 for round trip economy airline ticket
